  - a. The Bidder/ Purchaser shall make his own arrangement for getting required power connection, water and other facilities. Till date of acceptance of the offer, **MOCICOL shall be liable to pay arrears of rates & taxes, any dues of Statutory Authorities like Sales Tax dues, Sales Tax Incentive dues, Central Excise dues etc in respect of the said Plant and Machinery ( to be retained if deemed necessary.)**

- k) Brief background profile of Tenderer/Bidder  
If any of the above documents are not applicable to Tenderer, he/it shall specify it with reasons thereto. It will solely be discretion of Managing Director of MOCICOL to accept / entertain or reject any of the Tender in the interest of MOCICOL.
- L) Copy of gumasta licence as per Shop and Establishment Act, if applicable.
15. While dismantling, lifting and shifting the plant and machinery, the purchaser is required to take necessary precaution to avoid accident or incidences that may cause harm or loss to human life and environment. The purchaser shall shift the plant and machinery within 30 days from the date of full and final payment to MOCICOL and during such period, the risk will be on the purchaser.
16. On payment of the full purchase price, required documents ,agreements / invoices will be executed at the cost of purchaser.
